MOTION TO WITHDRAW AS INTERVENING PARTY**

NOW COME International Paper Company ("International Paper"), and Masonite Corporation ("Masonite"), by and through their attorneys, and move that this Court permit them to withdraw as intervening parties in the above-captioned matter.

IN FURTHERANCE, the Movants state as follows:

1. By pleading dated April 2, 2003, the Movants moved to intervene in the above-captioned action for the purpose of seeking clarification of this Court's Rehabilitation Order regarding The Home Insurance Company dated March 5, 2003. The Motion to Intervene was granted by Order dated April 7, 2003.
2. Subsequent proceedings in the Superior Court in the State of California for the City and County of San Francisco in the suit entitled International Paper Company, et al. v. Affiliated FM Insurance Company, et al., Docket No. 974350, have rendered moot the Movants' Motion to Clarify. See Notice of Withdrawal of Motion to Clarify being filed herewith. In light of this fact, the Movants have no immediate interest in the above-captioned suit.
3. The Movants wish to retain their right to seek intervention in this action in the event that further proceedings directly affect their interests.
4. Counsel for the Movants was unable to reach counsel for the Rehabilitator to obtain his position regarding this Motion.

B. Grant such other relief as may be just and proper.




