**LIQUIDATOR'S SUPPLEMENTAL STATEMENT IN SUPPORT OF
MOTION FOR APPROVAL OF
REINSURANCE COMMUTATION AGREEMENT WITH THE COPENHAGEN
REINSURANCE COMPANY LIMITED**

In accordance with the Order Establishing Procedures for Review of Reinsurance Commutation Agreements entered July 23, 2003 (the "Procedures Order"), on August 22, 2003, Roger A. Sevigny, Commissioner of Insurance for the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("The Home"), moved that the Court enter an Order approving a reinsurance commutation agreement between the Liquidator and The Copenhagen Reinsurance Company Limited ("Copenhagen").

The Liquidator shared the Copenhagen Commutation with the Guaranty Fund Commutation Committee which has entered into a confidentiality agreement with the Liquidator. See Liquidator's Motion for Approval of Commutation Review Procedures at ¶ 8. The Liquidator hereby reports that the Committee has advised through its counsel that after review it has no objection to the Copenhagen Commutation.
