**LIQUIDATOR'S MOTION TO RESCHEDULE STATUS CONFERENCE**

NOW COMES Roger A. Sevigny, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company, by and through counsel, and moves that the Court continue the status conference scheduled for September 17, 2004 and reschedule it in October 2004, preferably on October 15, 2004. As reasons therefor, the Liquidator states as follows:

1. The Court has scheduled a status conference on September 17, 2004 to discuss the status of outstanding matters concerning the ACE Companies.
2. The Liquidator and the ACE Companies are waiting for a decision from the New Hampshire Supreme Court on the appeal of the Court's April 29<sup>th</sup> Order. The decision in that appeal will have a direct bearing on matters concerning the ACE Companies.
3. The Liquidator anticipates that a decision from the New Hampshire Supreme Court may be forthcoming by the end of September 2004, and the status conference may be more productive if held after decision of the appeal.
4. The ACE Companies assent to the requested rescheduling of the status conference.

WHEREFORE, the Liquidator respectfully requests that this Court:

- A. Grant this Motion to Continue Status Conference currently scheduled for September 17, 2004;
- B. Reschedule the status conference to October 15, 2004; and
- C. Grant such other and further relief as justice may require.
