AGREEMENTS WITH LONDON REINSURERS


On consideration of the motion of Roger A. Sevigny, Commissioner of Insurance for the State of New Hampshire, as Liquidator ("Liquidator") of the The Home Insurance Company ("Home") for an order approving eleven (11) Reinsurance Commutation Agreements, Settlements and Releases (the "Agreements") between Home and certain London market reinsurers and reinsurance pools (the "Reinsurers"), and the supporting confidential affidavit of Peter A. Bengelsdorf, it is hereby ORDERED as follows:


ORDER
