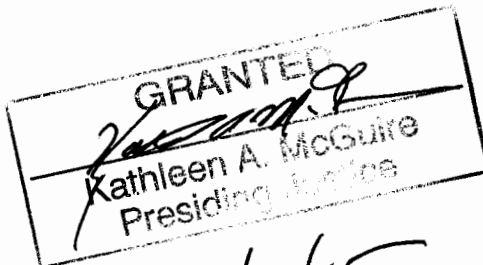
Counsel for Ace Companies assents to the relief sought by this Motion.
