Sevigny, Commissioner of Insurance of the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home") and US International Reinsurance Company (collectively, the "Companies"), and withdraws the Liquidator's motion for approval of release of proofs of claim dated October 6, 2005 without prejudice to submission of a further motion. Consideration of the ramifications of the motion across a wider range of proofs of claim, the information presented on certain types of proofs of claim, and the logistics of access lead the Liquidator to withdraw the motion at this time.




