**LIQUIDATOR'S MOTION TO FILE OPPOSITION
TO CIC'S MOTION TO RECONSIDER ORDER APPROVING
LIQUIDATOR'S CLAIMS REPORT UNDER SEAL**

Roger A. Sevigny, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), moves to file under seal the Liquidator's Opposition to CIC's Motion to Reconsider the Order Approving Liquidator's Report of Claims and Recommendations as of December 15, 2005. As reasons therefore, the Liquidator states:

1. CIC's motion to reconsider raises issues concerning the settlement agreement between Home and Zurich Versicherung Aktiengesellschaft (Deutschland) ("Zurich"), which is the successor to Agrippina Versicherung Aktiengesellschaft ("Agrippina"). The settlement agreement contains information confidential to Agrippina, and the Liquidator's motion for approval of that agreement, including the settlement agreement itself, were placed under seal by order of the Court on January 14, 2005. A copy of the Court's order is attached as Exhibit A. CIC has appropriately moved to file its motion for reconsideration (which includes the papers placed under seal on January 14, 2005 as exhibits) under seal.

2. The Liquidator's opposition to CIC's motion for reconsideration responds to CIC's arguments concerning the settlement agreement, and also includes the settlement agreement placed under seal on January 14, 2005. The Opposition should also be placed under seal.

WHEREFORE, the Liquidator respectfully requests that the Court enter an order in the form submitted herewith placing the Liquidator's opposition to CIC's motion for reconsideration under seal.




ORDER PLACING MOTION CONCERNING
