**ORDER APPROVING SETTLEMENT AGREEMENT
WITH GEORGIA-PACIFIC**

On consideration of the motion of Roger A. Sevigny, Insurance Commissioner for the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), for an order approving a Settlement Agreement and Mutual Release ("Settlement Agreement") between Georgia-Pacific LLC, as legal successor to Georgia-Pacific Corporation, ("Georgia-Pacific") and the Liquidator, and the supporting Affidavit of Peter A. Bengelsdorf, it is hereby found and ORDERED as follows:

1. The Settlement Agreement is reasonable, prudent, and in the best interests of the liquidation of Home;
2. The Liquidator's Motion for Approval of Settlement Agreement with Georgia-Pacific is granted, and the Settlement Agreement is approved.
3. The Liquidator's recommendation concerning Georgia-Pacific's proofs of claim is approved and Georgia-Pacific's claim is allowed as a Class II claim in the aggregate amount of \$7,000,000.
