ORDER APPROVING SETTLEMENT AGREEMENT
WITH WISCONSIN ENERGY


On consideration of the motion of Roger A. Sevigny, Insurance Commissioner for the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), for an order approving a Settlement Agreement and Mutual Release ("Settlement Agreement") between Wisconsin Energy Corporation and its subsidiaries Wisconsin Electric Power Company (on its own behalf and as successor by merger to Wisconsin Southern Gas Company) and Wisconsin Gas Company (hereinafter collectively referred to as "Wisconsin Energy") and the Liquidator, and the supporting Affidavit of Peter A. Bengelsdorf, it is hereby found and ORDERED as follows:

1. The Settlement Agreement is reasonable, prudent, and in the best interests of the liquidation of Home;
2. The Liquidator's Motion for Approval of Settlement Agreement with Wisconsin Energy is granted, and the Settlement Agreement is approved; and
3. The Liquidator's recommendation concerning Wisconsin Energy's proofs of claim is approved and Wisconsin Energy's claim is allowed as a Class II claim in the aggregate amount of \$6,750,000.
