**LIQUIDATOR'S MOTION TO
REMOVE CERTAIN PERSONS FROM THE SERVICE LIST**

Roger A. Sevigny, Insurance Commissioner for the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), moves that the Court enter an order in the form submitted herewith to remove certain persons from the service list in this proceeding. WHEREFORE, the Liquidator respectfully requests that this Court issue an order to remove the names of the persons listed above from the service list.





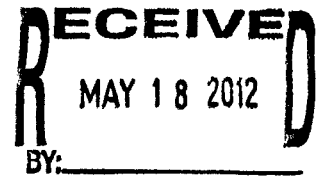
