**JOINT MOTION TO SET SCHEDULE
FOR FILINGS REGARDING WESTERN TRUST'S OBJECTION**

Roger A. Sevigny, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of the Home Insurance Company ("Home"), and the Western Asbestos Settlement Trust ("Western Trust"), hereby jointly request that the Court set the following schedule regarding the Western Trust's Objection to the Liquidator's Allowance and Treatment of Certain Claims of the California Insurance Guarantee Association ("Objection"): (1) the Liquidator's opposition to the objection shall be due on March 10, 2016, and (2) the Western Trust's reply, if any, shall be due on March 31, 2016. As reasons therefor, the Liquidator and Western Trust state:


1. In light of the issues presented by the Objection and present schedules, the Liquidator requests and the Western Trust assents to an extension of time to file the Liquidator's opposition to and including March 10, 2016.

2. In light of the issues, the Western Trust anticipates filing a reply, and it requests and the Liquidator assents to the filing of such a reply on or before March 31, 2016.

WHEREFORE, the Liquidator and the Western Trust request that the Court set a schedule for the Objection under which (1) the Liquidator's opposition is due on or before March 10, 2016, and (2) the Western Trust may file a reply on or before March 31, 2016.
