**LIQUIDATOR'S ASSENTED-TO MOTION FOR AN EXTENSION OF TIME
TO FILE OPPOSITION TO BRIDGESTONE'S MOTION TO RECOMMIT**

John R. Elias, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company, hereby moves that the Court extend the time for the Liquidator to file his opposition to the Objections to the Referee's Report and Motion to Recommit to Referee for Further Proceedings ("Motion to Recommit") filed by claimant Bridgestone Americas Tire Operations, LLC ("Bridgestone") to and including January 15, 2019. As reasons therefor, the Liquidator states:

1. On November 20, 2018, Bridgestone filed its Motion to Recommit. That same day, Bridgestone filed a motion for an extension of time to file its brief in support of the Motion to Recommit to December 14, 2018. The motion for extension of time stated that the factual record is extensive and the legal issues complex. The Liquidator assented to that motion.
2. Bridgestone will file its brief in support of the Motion to Recommit on December 14, 2018.
3. In light of the extensive factual record and the legal issues involved, and in light of the upcoming holidays, the Liquidator requests an extension of time to oppose the Motion to Recommit of 22 days, to and including January 15, 2019.

4. Counsel for the Liquidator has consulted with counsel for Bridgestone, and Bridgestone assents to the requested extension of time.

WHEREFORE, the Liquidator requests that the Court extend the time to file an opposition to Bridgestone's Motion to Recommit to and including January 15, 2019.
