Insured/Claimant Catholic Foreign Mission Society of American Inc. aka


Maryknoll Father and Brothers (“Maryknoll”) hereby submits its objection to the Motion for
Approval of Claim Amendment Deadline filed by the Liquidator.

Maryknoll has submitted several claims to The Home under a policy issued to Maryknoll by The Home for the period 1970 to 1973, Policy No. HEC 9792965. The claims relate to suits filed against Maryknoll in Hawaii regarding alleged sexual abuse by personnel that allegedly worked for Maryknoll. The Hawaii State Legislature has consistently extended the statute of limitations for the filing of such claims. The latest extension is until June 30, 2020. Consequently, new, additional claims within The Home's policy period may be filed against Maryknoll.

Maryknoll upheld its end of the bargain by paying all premiums for the policy issued by The Home. Therefore, Maryknoll objects to the Motion seeking to impose a final submission of proofs of claim in The Home liquidation.


