**LIQUIDATOR'S OBJECTION TO
CLAIMANT'S SEPTEMBER 4, 2009 FILING**

Roger A. Sevigny, Commissioner of Insurance of the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), hereby objects to the Claimant's filing of September 4, 2009. As reasons therefor, the Liquidator states as follows:


1. Claimant's filing dated September 4, 2009 seeks reconsideration of the Referee's Order dated August 19, 2009, additional discovery and further delay in briefing this matter.
2. The Referee's Order dated August 19, 2009 denied similar requests made by Claimant in his filing dated August 8, 2009, although the Referee extended the briefing schedule originally set in the Order dated June 15, 2009.
3. The filing presents no reason that would warrant reconsideration or additional discovery. Claimant should brief the issues specified in the Referee's Order of June 15, 2009 and restated in the Order dated August 19, 2009. If he chooses, he may as part of that briefing contend that additional discovery is necessary to resolve the issues, and the Referee may then consider the question in the context of full briefing of the dispositive issues. There is, however, no reason to further delay briefing in this matter.

Wherefore, the Liquidator requests that the Referee deny the relief sought in Claimant's filing dated September 4, 2009 and direct that Claimant proceed with briefing of the matters listed in the Referee's Orders dated June 15, 2009 and August 19, 2009.


