**JOINT REQUEST FOR DISMISSAL WITHOUT PREJUDICE**

P.J. Cleaners, Inc. ("P.J. Cleaners"), and Roger A. Sevigny, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of The Home Insurance Company ("Home"), jointly request that this matter be dismissed without prejudice as premature. As reasons therefor, the parties state:

1. This disputed claim proceeding appears to have been initiated in response to an inquiry by P.J. Cleaners directed to the Liquidation Clerk about the status of P.J. Cleaners' claim. However, P.J. Cleaners' claim has not yet progressed through the determination process to the point where a disputed claim proceeding is appropriate. The claim is still pending before the Liquidator on P.J. Cleaners' Request for Review.

2. P.J. Cleaners filed a proof of claim in the Home liquidation proceeding. The Liquidator issued a Notice of Determination on December 23, 2014. On January 20, 2015, P.J. Cleaners submitted a Request for Review to the Liquidator pursuant to Section 7(a) of the Restated and Revised Order Establishing Procedures Regarding Claims Filed with The Home Insurance Company in Liquidation (January 19, 2005) ("Claims Procedures Order"). While there has been correspondence since that time, the Liquidator has not issued a Notice of Redetermination pursuant to Section 7(b) of the Claims Procedures Order. The Request for

Review remains pending, and the Liquidator and P.J. Cleaners will be addressing the matter in that context.

3. A disputed claim proceeding will be presented only after the Liquidator issues a Notice of Redetermination and in the event P.J. Cleaners files an Objection with the Court. See Claims Procedures Order § 8.

WHEREFORE, P.J. Cleaners and the Liquidator jointly request that this disputed claim proceeding be dismissed without prejudice.


