
- a) I, Mariana Lanc, Claimant in this action, duly state that I am fully mentally disabled, poor person since 1993, as a result of a legal negligence. Additionally I am handicapped by very limited command and understanding of an English language and no understanding legal language what so ever. I am getting the help with an English writing,
- b) I am not attorney or familiar with the legal procedures , nor ability or understanding to represent myself in legal proceedings, nor can I find the legal representation for a legal malpractice action (all my past attorneys had a conflict of interest having their professional liability insurance with HOME REM INSURANCE CO.),
- c) that this case was sabotaged by all my previous attorneys and their professional liability insurance carrier HOME REM INSURANCE CO. who were trying to destroy this case, with very strong merits, and to destroy me personally mentally and financially since 1985 till present to cover up their wrongs (only 25 years),
- d) that I mailed to this Court my **"OBJECTION TO "NOTICE OF DETERMINATION" FOR DISALLOWED CLAIM"** Proof of Claim No.: CLMN380502-01 on October 22, 2009, delivered timely on Oct. 26, 2009 to Office of the Clerk, Merrimack County Superior Court, and **I never received the Courts' decision on it,**
- e) that I received the letter from "Rackemann, Sawyer & Brewster P.C. the letter dated 11/20/2009, for "APPOINTED REFEREE" in this dispute "EXHIBIT-A",
- f) that from this letter it was my understanding that Eric A. Smith from Rackemann, Sawyer & Brewster P.C. "BEFORE THE COURT-APPOINTED REFEREE", is appointed impartial referee by the Court in this case,
- g) that due to my understanding on Nov. 29, 2009 I offered to Eric A. Smith by e-mail my full cooperation and all needed documents which I have in possession which may help him to support my case. He never responded to it,
- h) that I received from adversary-Office of the Liquidation Clerk The Home Insurance Co. the letter dated January 26, 2010, (not Court's decision) "EXHIBIT -B", stating that I missed my time to respond and that they are extending it 10 days from that date,

- i) that the letter dated January 26, 2010 came as a shock to me because I wasn't aware that I was supposed to respond to anything at all, it was my understanding that it was taken care of by APPOINTED REFEREE.

- k) that enclosed is timely returned **signed** "ACKNOWLEDGMENT OF RECEIPT", which I do not understand the meaning of.
I am "rejecting the determination and intend to file a separate Objection with the Court.
I do not understand wording in above document for my action,

- l) I do not understand why the adversary- Home Insurance Co. is making a decisions and demands from me to sign paperwork to release some information "Exhibit-B" instead of the Merrimack County Superior Court to which I sent my objection to Home Insurance Co. "Notice of Determination". Neither I received any decision made by "Office of the Liquidation Clerk" prior to letter dated January 26, 2010.


