ASSENTED-TO MOTION TO EXTEND TIME TO PROPOUND DISCOVERY

Claimant Unionamerica Insurance Company Limited ("Unionamerica") respectfully requests that the deadline to to submit its discovery be extended by fifteen days, to and including September 8, 2009, and that all other deadlines – which would run from that date – remain the same. As grounds for this motion, Unionamerica states:

- 1. The Structuring Order dated June 15, 2009 required Century Indemnity Company ("CIC") to a file brief summary of position. From that point, Unionamerica has 45 days to propound discovery; then CIC has 45 days to object or respond; then Unionamerica has 30 days to file its brief; then CIC has 45 days to file its brief; and then Unionamerica has 14 days to file its reply.
- 2. CIC submitted its summary of position, and Unionamerica's discovery is currently due August 24, 2009. Unionamerica has nearly completed its discovery, but summer vacation schedules have prevented it from finalizing the requests. Unionamerica requests an extension of 15 days to accommodate the vacation schedule of the individuals necessary to complete the requests.
 - 3. CIC has graciously assented to this extension of time.

WHEREFORE, Unionamerica respectfully requests that the deadline for it to submit its discovery to CIC be extended to September 8, 2009 and that all remaining deadlines run from that date.
