MOTION TO PARTICIPATE


Century Indemnity Company (“CIC”), ACE Property and Casualty Insurance Company, Pacific Employers Insurance Company and ACE American Reinsurance Company (collectively, the “ACE Companies”), by their attorneys, Lovells and Orr & Reno P.A., respectfully submit this motion to participate in the above-captioned disputed claim proceeding. The ACE Companies further state:

1. The ACE Companies’ right to participate arises pursuant to paragraph 9(b) of the Restated and Revised Order Establishing Procedures Regarding Claims Filed with The Home Insurance Company in Liquidation, dated January 19, 2005. This right has been assented to by the Liquidator of Home under paragraph 2.13 of the Claims Protocol, approved by the Court on November 12, 2004. The Claims Protocol is the product of extensive negotiations between the Liquidator and CIC, and describes the process for CIC’s continued undertaking of Home’s administration and service obligations under the Insurance and Reinsurance Assumption Agreement, dated January 31, 1984 and the Reinsurance Treaty and Management Agreement, dated January 31, 1984.

2. The ACE Companies’ right to interpose defenses in this proceeding on behalf of Home arises under the Insurance and Reinsurance Assumption Agreement.
