**MOTION TO WITHDRAW OBJECTION TO LIQUIDATOR'S NOTICE OF  
DETERMINATION OF CLAIM WITHOUT PREJUDICE**

**AND NOW COMES** Tenova Inc. f/k/a Tenova Core Inc. f/k/a Core Furnace Systems Corp. f/k/a Techint Technologies Inc., the successor in interest of Salem Furnace Company (collectively, "Tenova"), by and through its undersigned counsel, Meyer, Unkovic & Scott LLP, and respectfully submits its Motion to Withdraw its December 10, 2018 Objection to the Liquidator's October 15, 2018 Notice of Determination **Without Prejudice** as follows:

1. On or about October 15, 2008, Tenova received a letter from the Liquidator regarding a Notice of Determination of Tenova's Proof of Claim.
2. Respectfully, Tenova disagrees with the Liquidators' Notice of Determination and rationale therein and therefore filed an Objection with this Court on December 10, 2018.
3. On or about that same date, December 10, 2018, the Liquidator agreed to deem Tenova's as-filed Objection a "Request for Review" such that Tenova would be permitted to engage in the Request for Review process instead of the Disputed Claim process.
4. In this respect, Tenova will be permitted to file an Objection as desired upon a Redetermination in accordance with this Court's Restated and Revised Order Establishing

Procedures Regarding Claims Filed With the Home Insurance Company in Liquidation, thereby rendering the Objection filed with the Court on December 10, 2018, moot.

5. For the foregoing reasons, Tenova respectfully requests this Court grant its Motion and withdraw its December 10, 2018 Objection **without prejudice**.

**WHEREFORE**, Tenova prays that this Honorable Court shall grant its Motion and withdraw its December 10, 2018 Objection **without prejudice**.
