**LIQUIDATOR'S ASSENTED-TO MOTION FOR CONSOLIDATION OF
DISPUTED CLAIM PROCEEDINGS 2006-HICIL-18 AND 2006-HICIL-21**

Roger A. Sevigny, Insurance Commissioner for the State of New Hampshire, as Liquidator of The Home Insurance Company ("Liquidator"), hereby moves for an order consolidating the two disputed claim proceedings for claimant Winterthur Swiss Insurance Company ("Winterthur"). In support of this motion, the Liquidator states as follows:

1. Winterthur initiated 2006-HICIL-18 by filing an Objection with the Clerk of the Superior Court for Merrimack County on February 21, 2006 in response to the Liquidator's Notice of Determination ("NOD") dated January 18, 2006 regarding Proof of Claim ("POC") INTL278096.

2. Winterthur initiated 2006-HICIL-21 by filing an Objection with the Clerk of the Superior Court for Merrimack County on March 30, 2006 in response to the Liquidator's NOD dated February 22, 2006, also regarding POC INTL278096.

3. These two disputed claim proceedings arise from a single POC filed by Winterthur on June 8, 2004, which described the nature of the claims as “claims arising from various contracts of reinsurance.”

4. The two disputed claim proceedings both involve objections to the deduction of London Representative Fees.

5. It would be most efficient to address Winterthur’s two objections concurrently.


6. Both Winterthur and Century Indemnity Company have assented to the requested consolidation.

WHEREFORE, the Liquidator respectfully requests that 2006-HICIL-18 and 2006-HICIL-21 be consolidated and treated as a single disputed claim proceeding.
