**JOINT MOTION TO EXTEND TIME  
FOR DEPOSITIONS BY ONE WEEK**

Roger A. Sevigny, Commissioner of Insurance for the State of New Hampshire, as Liquidator (“Liquidator”) of The Home Insurance Company (“Home”), and Century Indemnity Company (“CIC”), jointly move that the Referee enter an order extending the time for the completion of depositions in this matter by one week. As reasons therefor, the parties state:

1. Under the Scheduling Order issued February 22, 2011, the deadline for completion of depositions was set as May 2, 2011. Also on February 22, 2011, the Referee issued a ruling on the Liquidator’s motion to compel. CIC produced documents in response to the ruling on April 8, 2011.

2. The Liquidator is seeking to depose the most knowledgeable person at CIC concerning a number of topics, including topics regarding the documents recently produced by CIC.

3. The parties have conferred regarding deposition scheduling. Counsel for the Liquidator is out of the office during the week of April 18, 2011, and CIC’s designated witness is not available during the week of April 25, 2011.

4. To allow for the deposition of CIC's designated witness during the week of May 2, 2001, the parties jointly request that the time for completion of depositions be extended by one week to May 9, 2011. This will not affect the remaining deadlines in the Scheduling Order.


WHEREFORE, the parties jointly request that this motion be granted and that the Referee enter an order extending the time for completion of depositions to and including May 9, 2011.


