**HENRY COMPANY'S UNOPPOSED MOTION FOR STAY**

Henry Company ("Henry"), by its undersigned attorneys, hereby submits this Motion for Stay of the proceedings relating to its objections to the Notice of Determination, dated April 29, 2005, and resent on May 6, 2005, concerning Henry Company's proof of claim.

1. Henry and its predecessor, Monsey Products Company ("Monsey"), have faced many asbestos-related claims which they claim are covered by insurance policies sold by The Home Insurance Company in Liquidation and its predecessors in interest ("Home").

2. The referee previously granted a stay of the proceedings until May 15, 2006, and until July 17, 2006. The referee stated that the evidentiary hearing and simultaneous briefs would be due on July 31, 2006, absent an application for further stay prior to July 17, 2006.

3. Henry hereby applies for an indefinite extension of the stay of these proceedings.

4. Home has stated that it does not object to such a stay.

WHEREFORE, Henry respectfully requests that an order be entered staying this action indefinitely, until either party revokes the stay with 30 days notice to the other party and to the Liquidator.
