**JOINT REQUEST TO EXTEND DATE FOR FILING OF JOINT REPORT
AND TO RESCHEDULE RELATED TELEPHONIC CONFERENCE**

Century Indemnity Company (“CIC”) and Roger A. Sevigny, Insurance Commissioner for the State of New Hampshire, as Liquidator (“Liquidator”) of The Home Insurance Company, jointly request that the November 19, 2012 date for the filing(s) regarding the impact of the Metex bankruptcy be extended to December 19, 2012 and the related telephonic conference scheduled for December 3, 2012 be continued until after December 19, 2012. As reasons therefore, the Liquidator and CIC state:

1. During the telephonic conference on November 9, 2012, the parties reported that Metex Manufacturing Corporation (“Metex”) had filed a bankruptcy petition that day and requested that the argument scheduled for November 13, 2012 be continued so the parties could assess the impact of the bankruptcy on this proceeding.
2. The Referee issued an order dated November 9, 2012, continuing the hearing on the merits and directing the parties to file by November 19, 2012 a joint report or separate position

papers regarding whether the hearing can proceed. The Referee also issued an order dated November 13, 2012 scheduling a telephonic conference for December 3, 2012.

3. In view of the recent nature of the Metex bankruptcy, the parties need additional time to appropriately assess its impact and prepare a joint report or, if necessary, separate filings as directed in the Referee's November 9, 2012 order.

4. To allow adequate time, the parties jointly request that the Referee extend the time for the filing(s) required by the November 9, 2012 order by thirty days, to Wednesday December 19, 2012. The parties also request that the related telephonic conference be rescheduled to a convenient date shortly after December 19, 2012.

WHEREFORE, the parties respectfully request that the Referee extend the time for the joint report or, if necessary, separate filings to December 19, 2012 and reschedule the related telephonic conference to a date shortly after December 19, 2012.


