LIQUIDATOR'S EIGHTH REPORT

I, Roger A. Sevigny, Insurance Commissioner ("Commissioner"), as Liquidator ("Liquidator") of The Home Insurance Company ("The Home") and US International Reinsurance Company ("USI Re") (collectively, the "Companies"), hereby submit this eighth report on the liquidations of the Companies, as of April 14, 2004, in accordance with RSA 402-C:25.

- Reinsurance commutations. The Court entered an order amending the 1. procedures for review of reinsurance commutation agreements on March 23, 2004. The Liquidator will accordingly seek approval of commutation agreements where the preoffset present value of the commuted reinsurance is more than \$500,000, and will report on commutations involving lesser amounts as an appendix under seal to future reports.
- 2. AFIA compromise. The Liquidator has filed a motion for approval of the agreement and compromise with AFIA Cedents. The ACE Companies and Benjamin Moore & Co. filed objections, and the Liquidator submitted a reply. In an order entered after the status conference on April 9, 2003, the Court permitted further papers to be filed on April 16, 2004 and set a further hearing for April 23, 2004.

- 3. Operations. The Liquidator has filed a motion seeking approval of integrated compensation plans with respect to employees of the liquidation on April 5, 2004. The Liquidator has engaged SunGard Recovery Services LP to assist in developing a business disaster recovery plan. The plan involves disaster recovery relating to information technology operations, which has been completed and implemented. Development of the general business plan is ongoing. In the event that additional work may be needed from Risk Enterprise Management under the transition services agreement approved by the Court on August 6, 2003, the term of the agreement has been extended for an additional 30 day period to May 17, 2004.
- 4. <u>Proofs of Claim</u>. As of April 9, 2004, the liquidation had received over 2,100 proofs of claim asserting claims amounts in excess of \$669 million. Many proofs of claim do not state a claim amount.
- 5. <u>Publication notice of claim filing deadline</u>. In late March and early April, 2004, a second notice of the June 13, 2004 claim filing deadline in the form attached as Exhibit A was published in 94 newspapers and one trade publication.
- 6. <u>Canadian branch proceeding</u>. The Court approved the assumption reinsurance agreement concerning assumption of The Home's Canadian insurance obligations by a Canadian insurer on December 19, 2003. That transaction has closed, and the Liquidator's representatives are now engaged in discussions with the Canadian Provisional Liquidator concerning a possible timeline to repatriate excess funds to the Home estate in light of Canadian tax issues.

The liquidation of The Home includes the liquidation of other companies that were previously merged into The Home: The Home Indemnity Company, The Home Insurance Company of Indiana, City Insurance Company, Home Lloyds Insurance Company of Texas, The Home Insurance Company of Illinois, and The Home Insurance Company of Wisconsin.
